

Terms and Conditions cTrader Spring Giveaway

These Terms and Conditions (the “**Terms**”) govern participation in the cTrader Spring Giveaway (the “**Giveaway**”), organised and administered by cTrader Ltd, a company incorporated in the Republic of Cyprus with registration number HE 263204, whose registered address is situated at 78 Spyrou Kyprianou, Magnum Business Center, 3rd Floor, 3076 Limassol, Cyprus (“**cTrader**”). By participating, each entrant (“**Participant**”) confirms that they have read, understood and agreed to be bound by these Terms. Non-compliance with the Terms may result in disqualification.

1. Objective

- 1.1. The purpose of the Giveaway is to reward cTrader users and promote engagement within the cTrader community through the awarding of prop trading challenge coupons and cTrader Store bonus deposits.

2. Eligibility

- 2.1. The Giveaway is open to users of the cTrader platform and followers of the official cTrader social media channels.
- 2.2. Participants must be of legal age in their country of residence and must have the legal capacity to enter into binding agreements.
- 2.3. Participation shall be void if it is prohibited by applicable law.

3. Giveaway Period

- 3.1. The Giveaway runs from the **1st of April 2026** until the **26th of April 2026**.
- 3.2. Winners will be announced on the **29th of April 2026** via cTrader’s official social media channels.

4. How to Enter

- 4.1. To enter, Participants must complete the steps listed in the official Giveaway announcement.

5. Prizes

- 5.1. The prizes for the Giveaway across all social media channels are as follows:
 - 1st place: \$500 prop challenge and \$100 bonus deposit in cTrader Store
 - 2nd place: \$250 prop challenge and \$100 bonus deposit in cTrader Store
 - 3rd place: \$100 prop challenge and \$100 bonus deposit in cTrader Store.

5.2. The cTrader Store bonus deposit may be used toward eligible purchases of cBots, indicators, and plugins, and may cover up to 30% of the total order price.

5.3. All bonus deposits are non-withdrawable and have no cash value.

5.4. cTrader reserves the right to substitute any prize with another of equivalent value at its sole discretion.

5.5. All taxes, duties and other charges associated with the acceptance or use of a prize are the sole responsibility of the winner.

6. Winner Selection

6.1. Winners will be chosen at cTrader's discretion from among eligible entries.

6.2. cTrader reserves the right to verify eligibility and disqualify any Participant who provides false or incomplete information.

7. Disqualification

7.1. cTrader may disqualify any Participant who:

- Fails to follow the entry rules;
- Engages in fraudulent, unlawful or unethical behaviour;
- Uses fake, duplicate or inauthentic social media accounts;
- Comments on the relevant post more than once;
- Violates intellectual property rights or community guidelines.

8. Liability and Indemnity

8.1. Participants assume all risks associated with participation. To the maximum extent permitted by law, Participants release and hold harmless cTrader, its officers, employees, and affiliates from all claims, liabilities, losses or damages arising from participation in the Giveaway or use of any prize.

9. Modifications and Termination

9.1. cTrader reserves the right to amend, suspend or cancel the Giveaway or these Terms at any time without prior notice and without liability.

10. Data Protection

10.1. Personal data collected in connection with the Giveaway will be processed in accordance with cTrader's Privacy Policy and applicable data protection laws, including the GDPR, where applicable.

11. Governing Law and Jurisdiction

11.1. These Terms are governed by the laws of the Republic of Cyprus. Any disputes arising from or related to the Giveaway shall be subject to the exclusive jurisdiction of the courts of Cyprus.
